WHEREAS, the Mortgagor is well and truly indebted unto

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **Greenville**

State of South Carolina: **being shown and designated as Lot 102 on a Plat of ELIZA T. LOOPER PROPERTY, recorded in the RMC Office for Greenville County in Plat Book 5-J, at Page 51. Said lot fronts 50.02 feet on the southern side of Jasmine Drive; runs back to a depth of 151.2 feet on its eastern boundary; runs back to a depth of 152.3 feet on its western boundary, and has 50.0 feet across the rear.**

This is the same property conveyed to the Mortgagors herein by deed of C. H. Heaton and Louise B. Heaton, dated April 11, 1980, to be recorded simultaneously herewith.

"The Mortgagor covenants and agree that so long as this mortgage and the said not e secured hereby are insured under the National Housing Act, he will not execute or file for record any instrument which imposes a restriction upon the sale or occupancy of the mortgage property on the basis of race, color, or creed. Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

1. That he will promptly pay the principal of an interest on the indebtedness evidenced by the said note, at the times and in the manner herein provided. Privilege is reserved to pay the debt in whole, or in amount equal to, or more than, the monthly payments of the principal that are next due on the note, on the first day of any month prior to maturity, or if the Mortgagor has no intention of an intention to exercise such privilege is given at least thirty (30) days prior to maturity.
