RESOLUTION  
(AUTHORIZING BONDED INDEBTEDNESS)

BE IT RESOLVED THAT NORTHGATE BAPTIST CHURCH  
Greenville, South Carolina (hereinafter referred to as the Issuer) issue and sell its  
First Mortgage Bonds in the total aggregate amount of \$ 350,000.00 for the pur-  
pose of building a Family Life Center

and that sufficient revenue be appropriated and irrevocably assigned and pledged to pay the principal and all interest as the same shall come due and any Fiscal Agent fees.

That a Steering Committee be elected and instructed to select and approve, (in consultation with Security Church Finance, Inc.) the bond repayment schedule, the rate of interest, the type of bonds, the date the bonds shall began earning interest, the Paying Agent Bank, the Independent Trustee (if Mortgage Bonds), the Fiscal Agent, the necessary amount of proceeds to be escrowed, the date of the campaign, the bonding of the Treasurer, and any other decisions necessary to implement this bond issue and to enter into an agreement with Security Church Finance, Inc.

That all of the necessary instruments and documents pertaining to this bond issue including but not limited to:

- The agreement with Security Church Finance, Inc.
- The Resolution or Trust Indenture describing the terms and conditions of the issue
- The Deed of Trust or First Mortgages
- The Bonds and Escrow Agreements

shall be on forms furnished or approved by Security Church Finance, Inc. and approved and completed by an attorney-at-law retained by the Issuer and shall be signed for and on behalf of the Issuer by the following individuals, or their successors in office, who are authorized by the Articles of Incorporation or By-Laws of the Issuer, or state law\*
