NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Grove Township, and having the following metes and bounds, to-wit:

BEGINNING at point in Old Augusta Road 169.7 feet northeasterly from line of property of I. E. McDavid and running thence N. 62-30 W. 583.7 feet to a stake in ditch; thence northeasterly with ditch 356.1 feet to stake in said ditch; thence S. 59-00 E. 510 feet to the point in Old Augusta Road; thence with said road S. 40-30 W. 156.5 feet to the point of beginning, containing 3.2 acres, more or less.
