MORTGAGE OF REAL ESTATE
TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Gwendolyn C. Collins

(hereinafter referred to as Mortgagor) is well and truly indebted unto

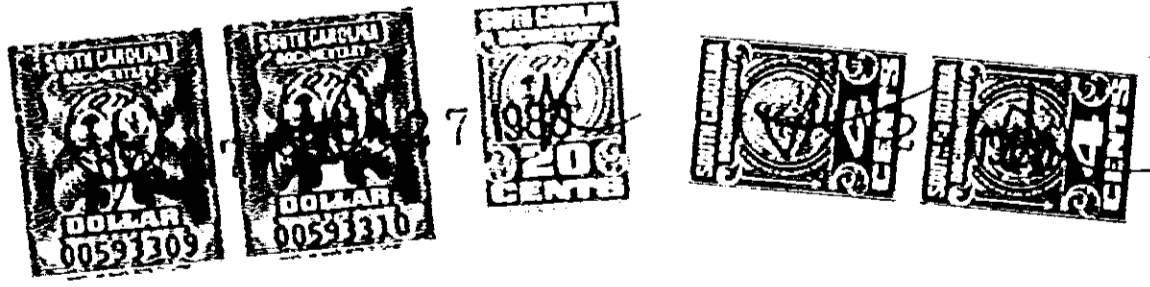
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and City of Greenville, being shown and designated as Lot 8 on a Plat prepared by James P. Willis, Surveyor, dated July 1, 1906, entitled SOUTH CHEROKEE PARK, recorded in the RMC Office for Greenville County in Plat Book A, at Page 130, and having, according to said Plat, the following metes and bounds:

BEGINNING at an iron pin on the southeastern side of Grove Road (formerly Golden Grove Road) at the joint front corner of Lots 8 and 9, and running thence with the line of Lot 9, S 63-00 E, 172 feet, more or less, to an iron pin on the western side of an alley; thence along said Alley, S 27-00 W 60 feet to an iron pin at the joint rear corner of Lots 7 and 8; thence along the line of Lot 7, N 63-00 W, 172 feet, more or less, to an iron pin on the southeastern side of Grove Road; thence with said Road, N 27-00 E, 60 feet to the point of beginning.
