WHEREAS, DON O. ROLLINS, SR.

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, known and designated as a part of Lots 28 and 29 of the J. R. West property as shown on Plat recorded in Plat Book C at Page 190 in the RMC Office for Greenville County and being more currently shown on Plat entitled Don O. Rollins, Sr. dated October 25, 1978 by Webb Mapping and Surveying Company and being more fully described in accordance with said Plat to-wit:

BEGINNING at an iron pin on the western side of Ledbetter Street and being the southeastern corner of said Lot 28 and running thence along the southern side of Lots 28 and 29 S. 75-02 W., 120 feet to an iron pin; thence N. 16-34 W., 65.5 feet to an iron pin; thence N. 27-35 E. 58.01 feet to an iron pin; thence N. 74-25 W., 79.51 feet to an iron pin on western side of Ledbetter Street; thence along Ledbetter Street S. 16-34 E., 109.1 feet to an iron pin being the point of beginning.
