(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

SIX THOUSAND Dollars (\$ 6,000.00) due and payable
in sixty (60) equal, consecutive monthly installments of \$133.47,
commencing August 1, 1980, and continuing thereafter until paid in full,

with interest thereon from date at the rate of 12% per centum per annum, to be paid: monthly
Borrower reserves the right to anticipate, in full or in part, at any time
without penalty.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 17 on a Plat of LYNNDAL Subdivision, recorded in the RMC Office for Greenville County in Plat Book WW, at Page 4, and having, according to said Plat, the following metes and bounds:

BEGINNING at an iron pin on the northwestern side of Brentwood Circle, joint front corner of Lots 16 and 17, and running thence with the common line of said Lots, N 9-26 W, 140 feet to an iron pin; thence with the rear line of Lot 17, N 80-34 E, 80 feet to an iron pin, joint rear corner of Lots 17 and 18; thence with the common line of said Lots, S 9-26 E, 140 feet to an iron pin on the northwestern side of Brentwood Circle; thence with said Circle, S 80-34 W, 80 feet to an iron pin, the point of beginning.
