NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land lying, being and situate on the northeast side of West Road about ½ mile southwest of the City of Greer, in Chick Springs Township, County and State aforesaid, and being known and designated as Lot No. Two (2) of Bonaire Acres as shown on plat prepared by C.C. Jones, Civil Engineer, dated Sept., 1964 and which plat has been recorded in the R.M.C. Office for said County in Plat Book GGG, page 188. This being a part of the property which was conveyed to grantor herein by W.M. Richardson, Jr. by deed recorded in said office in Deed Book 762, page 157. For a more particular description see the aforesaid plat.

The above described property is subject to the restrictive convenants as set forth in Deed Book 762, page 127 in the said R.M.C. Office.
