NOW THEREFORE, the Montgagor, in consideration of the said debt and sum of money aforesaid, and for better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of \$3.00 to him in hand by the Montgagee at and before the sealing and delivery of these presents hereby bargains, sells, grants and releases unto the Montgagee, its successors and assigns, the following described real estate situated in Greenville County, South Carolina: ALL that certain parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Cheel Poumship, about five niles north of Green, near Mashington Baptist Church, being shown as containing 0.92 acres on a plat of property prepared for Torry and Elizabeth D. Eller by Molfe and Huskey, Inc., Surveyors, dated October 21, 1976, recorded in Plat Book 4-0 at page 361, and having such netes and bounds as is thereby shown. RESERVING, HOWEVER, to the grantor, Miles Grain, his heirs and assigns, an easement and right of way for ingress and egress over the pavel drive along the west boundary line of said property, as shown on the above mentioned plat.

The Mortgagor covenants and agrees as follows:

- 2. To pay all taxes, levies and assessments which are or become liens upon the said real estate when due, and to exhibit promptly to the Mortgagee the official receipts therefor.
- 3. To provide and maintain fire insurance with extended coverage endorsement, and other insurance as Mortgagee may require, upon the building and improvements now situate or hereafter constructed in and upon said real property, in companies and amounts satisfactory to and with loss payable to the Mortgagee; and to deliver the policies for such required insurance to the Mortgagee.
- 4. In case of breach of covenants numbered 2 or 3 above, the Mortgagee may pay taxes, levies or assessments, contract for insurance and pay the premiums, and cause to be made all necessary repairs to the buildings and other improvements, and pay
