"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that certian piece, parcel or lot of land situate, lying and being in the County and State aforesaid on the head branch of Brushy Creek, branch waters of Reedy River about 2 1/2 miles West of the City of Greenville and originally containing about one (1) acre and being the same parcel or lot conveyed to Hampton Brown by Mrs. C.A. Mauldin by deed dated January 10, 1874 and this deed is intended to convey all our right, title and interest in said lot except the northern corner which is a strip of 140 feet by 150 feet conveyed by us to Ansel Arnold in 1913, Book 24, page 505 deed from Mrs. C. 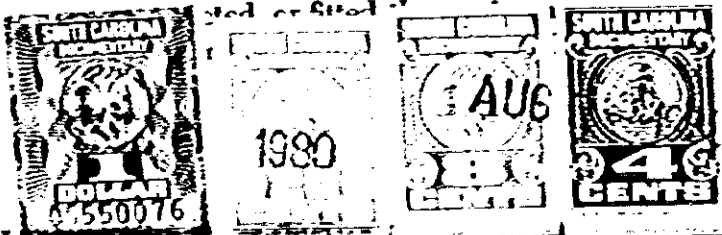
