MORTGAGE

THIS MORTGAGE is made this 6th day of AUGUST, 1980, between the Mortgagor, CYNTHIA JOYCE FISKE, ANDREA L. VOLPE AND CHARLES E. VOLPE, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

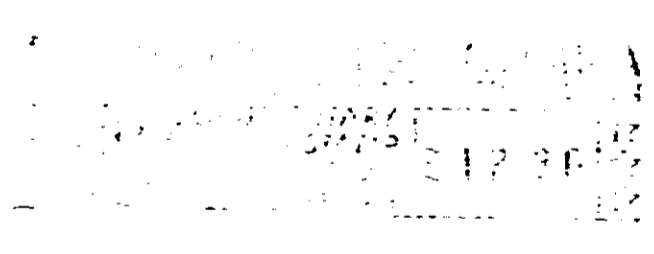
WHEREAS, Borrower is indebted to Lender in the principal sum of THIRTY-TWO THOUSAND AND NO/100 Dollars, which indebtedness is evidenced by Borrower's note dated AUGUST 6, 1980, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on SEPTEMBER 1, 2005.

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of GREENVILLE, State of South Carolina:

ALL that certain piece, parcel or lot of land, and the improvements thereon, situate, lying and being in the City and County of Greenville, State of South Carolina, and being known and designated as property of Charles E. Volpe, Andrea L. Volpe and Cynthia Joyce Fiske on a survey recorded in Plat Book 8-A, Page 72 (also known as Lot 68 on a plat of Overbrook Land Co., recorded in Plat Book E at Page 251), and having, according to the more recent plat, the following metes and bounds, to-wit:

BEGINNING at a point on East North Street, said point being 146.5 feet northeasterly from the intersection of East North Street and Bethel Street and running thence N. 48-32 W. 216.7 feet to a point; thence running N. 66-59 E. 84.5 feet to a point; thence running S. 48-04 E. 184.7 feet to a point; thence running with East North Street S. 41-28 W. 78.4 feet to the point of beginning.

TO HAVE AND TO HOLD unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are herein referred to as the "Property."

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
