BEGINNING at an iron pin on the Northwestern side of Rutherford Road, which iron pin is 165 feet Southwest from the intersection of said Road and Cool Springs Road, and running thence with the Northwestern side of said Road S. 51-10 W. 69 feet to an iron pin; running thence N. 37-53 W. 156.27 feet to an iron pin; running thence N. 51-30 E. 66.34 feet to an iron pin; running thence S. 36-52 E. 47.7 feet to an iron pin; running thence S. 26-27 E. 53.5 feet to an iron pin; running thence S. 50-03 E. 66.2 feet to an iron pin on the Northwestern side of Rutherford Road, point of beginning.
