MARCHANT, the owner and holder of that certain mortgage given by PLEASANTBURG UPHOLSTERING COMPANY, INC. in the amount of \$40,000.00 dated and recorded November 15, 1979 in mortgage vol. 1488 page 449 in the RMC Office for Greenville County, S.C., hereby release and forever discharge from the lien and effect of said mortgage the following described lot of land, to-wit:

Marchant" prepared by Dalton & Neves Co. dated February, 1979, and having according to said plat the following metes and bounds, to-wit:

BEGINNING on the northwest side of unnamed street (to be known as Craigwood Court) at the joint front corner of Lots No. 2 and 3 and running thence with the joint line of said lots, N. 33-21 W. 248.6 feet to an iron pin; thence turning S. 30-41 W. 171.8 feet to an iron pin in line of property now or formerly of J. Harold Mason; thence with the line of said property, S. 30-18 E. 177.5 feet to an iron pin; thence running S. 33-16 E. 35 feet to an iron pin on the northwest side of the turnaround of unnamed street (to be known as Craigwood Court); thence with said turnaround, N. 6-44 E. 70 feet to an iron pin; thence continuing, N. 81-44 E. 50 feet to an iron pin on the northwest side of said street; thence with said street, N. 51-44 E. 70 feet to the point of beginning.
