NOW, KNOW ALL MEN, that the mortgagor(s) in consideration of the said debt, and for the better securing the payment thereof, according to the conditions of the said Note; which with all its provisions is hereby made a part hereof; and also in consideration of Three Dollars to the said mortgagor in hand well and truly paid, by the said mortgage, at and before the sealing and delivery of these Presents, the receipt where of is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said mortgage, its (his) heirs, successors and assigns forever, the following described real estate:  All that certain parcel or lot of land with all improvements thereon containing 2.08 acres, more or less, situated on the west side of the road leading from Highway No.  415 to Mush Creek Baptist Church, Highland or Saluda Township, Greenville County, State of South Carolina, having courses and distances according to survey by H. S. Brockman, Registered Surveyor, as follows, to-wit:
BEGINNING on a point in the said road, joint corner of land now or formerly of M. C. McCarroll, and runs thence with McCarroll line S. 84-00 W. 19 feet to iron pin on the western bank of the road; thence continuing with the same course - S. 84-00 W for a total distance of 246 feet to an iron pin, joint corner of McCarroll land; thence with another line of McCarroll N. 49-30 W. 381 feet to stake or iron pin on said line; thence a new line S. 19-00 W. 250 feet to stake or iron pin; thence S. 71-00 E. 500 feet to point in the center of the said road (iron pin back on line on west bank of the road at 21 feet); thence with the said road N. 38-43 E. 225.5 feet to the beginning corner. This being the identical property conveyed to Donno Redding and Sheila Redding by deed of Clifton L. Hawkins on June 6, 1977, and recorded in the office of the RMC for Greenville County, S. C. in Deed Book 1058, page 134.
This is the identical property conveyed to Larry Redding and Betty S. Redding by deed of Donno Redding and Sheila Redding on August 18, 1980 and recorded 1.22-80 in the Office of the RMC for Greenville County in Deed Bk. 131, Page 106.  THE IS HEREBY UNDERSTOOD THAT THIS MORIGAGE CONSTITUTES A VALID FIRST LIEN ON THE ABOVE TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.
TO HAVE AND TO MOLD, all and singular the said Premises unto the said mortgagee, its (his) successors, heirs and assigns forever.
AND I (we) do hereby bind my (our) self and my (our) heirs, executors and administrators, to procure or execute any further necessary assurances of title to the said premises, the title to which is unencumbered, and also to warrant and forever defend all and singular the said Premises unto the eald mortgagee its (his) heirs, successors and assigns, from and against all persons lawfully claiming, or to claim the same or any part thereof.
AND IT IS AGREED, by and between the parties hereto, that the said mortgagor(s) his (their) heirs, executors, or administrators, shall keep the buildings on said premises, insured against loss or damage by fire, for the benefit of the said mortgages, for an amount not less than the unpaid balance on the said Note in such company as shall be approved by the said mortgages, and in default thereof, the said mortgages, its (his) heirs, successors or assigns, may offect such insurance and relimburse themselves under this mortgage for the expense thereof, with interest thereon, from the date of its payment. And it is further agreed that the said mortgagee its (his) heirs, successors or assigns shall be entitled to receive from the insurance moneys to be paid, a sum equal to the amount of the debt secured by this mortgage.
AND IT IS AGREED, by and between the said parties, that if the said mortgagor(s), his (their) helis, executors, administrators or assigns, shall fail to pay all taxes and assessments upon the said premises when the same shall first become payable, then the said mortgagee, its (his) heirs, successors or assigns, may cause the same to be paid, together with all penalties and costs incurred thereon, and reimburse thereaselves under this mortgage for the sums so paid, with interest thereon, from the dates of such payments.
AND IT IS AGREED, by and between the said parties, that upon any default being made in the payment of the said Note, when the same shall become payable, or in any other of the provisions of this mortgage, that then the entire amount of the debt secured, or intended to be secured hereby, shall forthwith become due, at the option of the said mortgages, its (his) heirs, successors or assigns, although the period for the
AND IT IS FURTHER AGREED, by and between the said parties, that should legal proceedings be instituted for the foreclosure of this mortgage, or for any purpose involving this mortgage, or should the debt hereby secured be placed in the hands of an attorney at low for collection, by suit or otherwise, that all costs and expenses incurred by the mortgager its (his) heirs, successors or assigns, including a reasonable counsel fee (of not less than ten per cent of the amount involved) shall thereupon become due and payable as a part of the debt
PROVIDED, ALWAYS, and it is the true intent and meaning of the parties to these Presents, that when the said mortgager, his (their) heirs, executors or administrators shall pay, or cause to be paid unto the said mortgages, its (his) heirs, successors or assigns, the said debt, with the interest thereon, if any shall be due, and also all same of money paid by the said mortgages, his (their) heirs, successors, or assigns, according to the conditions and agreements of the said note, and of this mortgage and shall perform all the obligations according to the true intent and meaning of the said note and mortgage, then this Deed of Bargain and Sale shall cause, determine and be void, otherwise it shall
