PARTIAL RELEASE OF LIEN

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of one dollar and other considerations, receipt whereof is hereby acknowledged, The Federal Land Bank of Columbia, the owner and holder of the security instrument hereinafter referred to and of the note(s) thereby secured does, subject to the conditions hereinafter stated, hereby release from the lien of that certain security instrument from W. A. Harrison

to The Federal Land Bank of Columbia, dated the 6th day of January, 1965, and recorded in the public records of Greenville County, State of South Carolina, in Mortgage Book 983, at page 33, the following described property, to-wit:

ALL that certain piece, parcel or lot of land, with all improvements thereon, in the County of Greenville, State of South Carolina, Oaklawn Township, bounded on the North by land of W. A. Harrison, on the East by Cooley Bridge Road, on the South by land of Clyde Chapman and on the West by Property of W. A. Harrison and further shown on plat entitled "Survey for Steve E. Harrison" by Carolina Surveying Company, dated June 16, 1980, recorded in Plat Book 4 at Page 292-293 RMC Office for Greenville County, reference to which is made for a more complete description. Said tract contains 1.0 acres total, more or less.

PROVIDED, HOWEVER, that the security of The Federal Land Bank of Columbia as described in the aforesaid security instrument shall, in all respects, except as to the premises hereinbefore described, be preserved and protected and that the lien of said security instrument, except as hereby released and discharged, shall remain in full force and effect and the terms, conditions and covenants thereof and of the note(s) thereby secured, shall remain unchanged.
