I, Paytralle D. Woodward

WHEREAS, I the said Paytralle D. Woodward

in and by my certain promissory note in writing of even date with these Presents, am well
and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of

LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

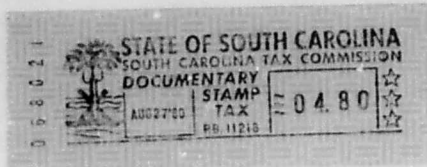
That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter
constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs
Township, located in the City of Greer on the Eastern side of Memorial Drive (formerly
Piedmont Ave.) and being shown as lots 38, 39 and 40 on plat of Morrow Park, plat book
E page 19A, Greenville County R.M.C. Office and being shown on a more recent plat made
for Ida A. Cox by Wolfe & Huskey, Inc., dated June 13, 1978 and having the following
courses and distances, to wit:

BEGINNING at an old pin on the eastern side of Memorial Drive 120 feet South from
corner of Hawkins Street and running thence S. 78-12 E., 139.9 feet to old pin; thence
