The Morigagor further ceremonis and agrees as follows:

- (1) That this mortgage shall secure the Mortgages for such for their sums as may be advanced hereafter, at the option of the Mortgages, for the payment of taxes, insurance premiums, public assessments, requires or other purposes pursuant to the covenants herein. - (3) That it will keep all improvements now existing or herester erected in good repair, and, in the case of a construction lean that it will continue construction until completion without interruption, and should it fail to do so, the Mortgages may, at its option enter upon said premises, make whatever repairs are necessary, including the completion of any construction work underway, and change the expenses for such remairs or the completion of such construction to the mortgage debt.
- (4) That it will pay, when dwo, all taxes, public assessments, and other governmental or monicipal charges, fines or other impositions against the mortgaged precises. That it will comply with all governmental and municipal faws and regulations affecting the mortgaged areasises.
- (5) That is hereby assigns all rents, issues and profits of the mortgaged premises from and after any default hereonder, and agrees that, should lead proceedings he instituted pursuant to this instrument, any judge having jurisdiction may, at Chambers or otherwise, appoint a receiver of the mortgaged premises, with full authority to take possession of the mortgaged premises and collect the rents, issues and profits, including a reasonable rental to be fixed by the Court in the event said premises are occupied by the mortgager and after deducting all charges and expenses attending such proceeding and the execution of its trust as receiver, shall apply the residue of the rents, issues and profits toward the payment of the debt secured hereby.
- (6) That if there is a default in any of the terms, conditions, or covenants of this morigage, or of the note secured hereby, then, at the option of the Mortgage, and some terms of the some immediately due and psyable, and this mortgage may be foreclosed. Should any legal proceedings be instituted for the foreclosere of this mortgage, or should the Mortgage become a party of any put involving this Martgage or the liftle to the premises described herein, or should the debt secured hereby or any part thereof be placed in the hands of any attorney at law for collection by suit or otherwise, all costs and expenses incurred by the Mortgagee, as a part of the debt secured hereby, and may be recovered and collected hereunder.
- (7) That the Mortgagor shall hold and enjoy the premises above conveyed until there is a default under this mertgage or in the mote secured hereby. It is the true meaning of this instrument that if the Mortgagor shall fully perform all the terms, conditions, and coverants of the mortgage, and of the note secured hereby, that then this mortgage shall be utterly null and void; otherwise to remain in full force and virtue.
