with interest thereon from _____ date _____ at the rate of **12%** per centum per annum, to be paid: **semi-annually**

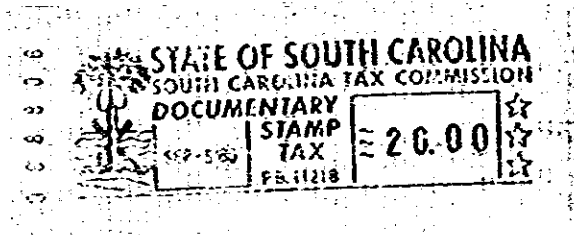

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, being known and designated as **Lot 188** of a subdivision known as **COACH HILLS** as shown on plat recorded in plat book **4-X** page **94** the RMC Office for Greenville County, S.C., and having the following metes and bounds, to-wit:
