One Hundred and No/100 Dollars (\$100.00) per month commencing on October 1, 1980, and continuing on like day thereafter until paid in full

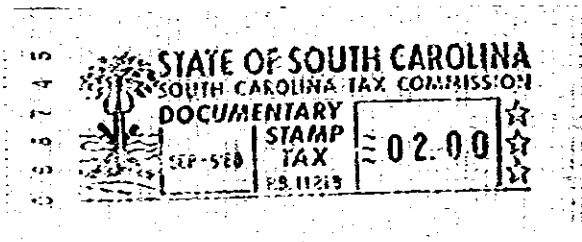
with interest thereon from date at the rate of Eight **(8%)** per centum per annum, to be paid: **monthly**
