THIS MORTGAGE is made this 18th day of September 19 80, between the Mortgagor, RONALD C. AYERS, JR. and CHERYL M. AYERS

(herein "Borrower"), and the Mortgagee, UNITED FEDERAL SAVINGS AND LOAN ASSOCIATION OF FOUNTAIN INN, a corporation organized and existing under the laws of the United States of America, whose address is 201 Trade Street, Fountain Inn, S. C. 29644. (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of FIFTY THOUSAND AND NO/100ths Dollars, which indebtedness is evidenced by Borrower's note dated September 18, 1980 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on January 1, 2011.

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville State of South Carolina: in Austin Township, fronting on the northwesterly side of S. C. Highway 14 a distance of 75 feet and containing three (3) acres as shown on a plat entitled, "Property of R. C. Ayers, Jr.", prepared by C. O. Riddle, Surveyor, originally dated March 6, 1978 and revised on September 10, 1980, which plat is to be recorded of even date herewith.

THIS is a portion of a 5.59 acre tract conveyed to the Mortgagor Ronald C. Ayers, Jr. by deed of R. V. Magill, recorded on April 9, 1978 in Deed Book 1077, Page 386. By deed to be recorded of even date herewith the said Ronald C. Ayers, Jr. is conveying an undivided one-half interest in the subject three (3) acres to the co-mortgagor, Cheryl M. Ayers.
