NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

GREENVILLE, SOUTH CAROLINA, AS EXECUTOR OF THE ESTATE OF LILLIAN D HARTSELL, IN THE STATE AFORESAID, IN CONSIDERATION OF PROVISIONS CONTAINED IN THE WILL OF THE SAID LILLIAN D HARTSELL, DECEASED, HAS GRANTED, BARGAINED, SOLD AND RELEASED, AND BY THESE PRESENTS DOES GRANT, BARGAIN, SELL AND RELEASE UNTO THE SAID ANNA WICKER, HER HEIRS AND ASSIGNS, FOREVER.

ALL THAT CERTAIN PIECE, PARCEL OR LOT OF LAND, SITUATE, LYING AND BEING IN THE CITY OF GREENVILLE, COUNTY OF GREENVILLE, STATE OF SOUTH CAROLINA, AND ACCORDING TO A PLAT PREPARED OF SAID PROPERTY BY C. FIDDLE, R.L.S., NUMBER 4, 1977, AND WHICH SAID PLAT IS RECORDED IN THE R.M.C. OFFICE FOR GREENVILLE COUNTY, SOUTH CAROLINA, IN PLAT BOOK 2-K, AT PAGE 100, HAVING THE FOLLOWING COURSES AND DISTANCES, TO-WIT:

BEGINNING AT AN OLD IRON PIN ON THE EDGE OF PINCKNEY STREET, JOINT FRONT CORNER OF PROPERTY NOW OR FORMERLY BELONGING TO WITHERS AND RUNNING THENCE WITH COMMON LINE WITH THE SAID WITHERS, S. 49-50 E. 167.57 FEET TO AN OLD IRON PIN, THENCE, N. 41-53-30 W. 44.1 FEET TO AN OLD IRON PIN, THENCE, N. 43-02 E. 171.75 FEET TO AN OLD IRON PIN ON THE EDGE OF PINCKNEY STREET, THENCE RUNNING WITH SAID STREET, S. 37-39 E. 50 FEET TO AN OLD IRON PIN ON THE EDGE OF PINCKNEY STREET, THE POINT OF BEGINNING.

THE WITHIN CONVEYANCE IS MADE PURSUANT TO THE PROVISIONS CONTAINED IN ARTICLES XI AND XXV OF THE WILL OF THE SAID LILLIAN D HARTSELL. THE SAID LILLIAN D HARTSELL DIED TESTATE, SEPTEMBER 9, 1977 AND HER SAID ESTATE IS NOW BEING ADMINISTERED BY THE PROBATE COURT FOR GREENVILLE COUNTY, SOUTH CAROLINA, AS WILL APPEAR BY REFERENCE TO RECORDS FILED IN SAID COURT IN APARTMENT 1484, FILE 16.

TO HAVE AND TO HOLD ALL AND SINGULAR THE PREMISES BEFORE MENTIONED UNTO THE SAID ANNA WICKER, HER HEIRS AND ASSIGNS, FOREVER.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner: it being the intention of the parties hereto that all fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
