We, Steven M. Steading and Donna H. Steading

SEND GREETING:

WHEREAS, we the said Steven M. Steading and Donna H. Steading

in and by their certain promissory note in writing of even date with these Presents, are well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of **Thirty Thousand & No/100** ----- (\$ **30,000.00** ) Dollars, with interest from the date hereof at the rate of **twelve** per cent ( **12** %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of **Three Hundred Thirty & 33/100** -----

Beginning at corner of Betty Holtzclaw northeast corner of property herein described and running thence along her line S. 35-35 E., 701.2 feet to old pin near creek, being 145 feet S. 63-00 W., from large poplar, old corner; thence S. 63-00 W., 145 feet to old pin; thence with another line of Betty Holtzclaw N. 38-26 W., 638.8 feet to southern side of Brushy Creek Road; thence with the southern side of said road N. 39-17 E., 60 feet to pin; thence still with road N. 41-15 E., 100 feet to pin; thence N. 45-20 E., 20 feet to pin and the beginning corner and containing 2.45 acres, more or less and shown as lot No. 2A on said plat.
