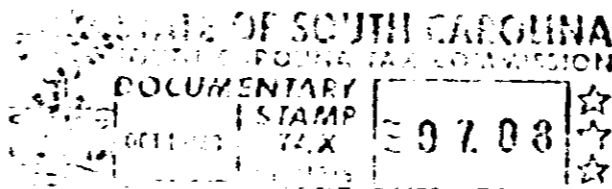
THIS MORTGAGE is made this 1st day of October, 1980, between the Mortgagor, Eldego Associates, a South Carolina general partnership, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Seventeen Thousand Six Hundred Fifty (\$17,650.00) --- Dollars, which indebtedness is evidenced by Borrower's note dated October 1, 1980, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on October 1, 2003.....;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that certain piece, parcel or unit, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on or near Cleveland Street, being known and designated as Unit No. 12-C of McDaniel Heights Horizontal Property Regime as is more fully described in Master Deed dated February 28, 1979, and recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 1098 at Pages 337 through 404, inclusive, and survey and plat plan recorded in the R.M.C. Office for Greenville County in Plat Book 6V at Pages 52 through 54.
