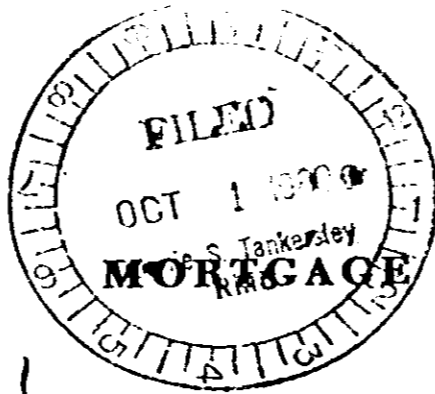

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land in the City of Mauldin, County of Greenville, State of South Carolina, situate, lying and being on the northeastern side of Stoney Creek Drive, and being known and designated as Lot No. 87 on plat of Forrester Woods Subdivision, Section 7, recorded in the RMC Office for Greenville County, South Carolina, in plat book 5-P, at pages 21 and 22, and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.

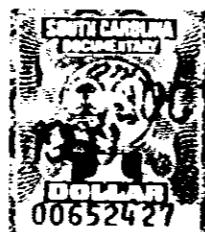
This conveyance is made subject to such easements, restrictions, or rights of way as may appear of record or on the premises.
