TO ALL WHOM THESE PRESENTS MAY CONCERN:

THIS MORTGAGE, made this 30th day of September, 1980, by William E. Poag, III  
and Peggy W. Poag hereinafter called the Mortgagor, in the State aforesaid, Witnesseth:

WHEREAS, the said Mortgagor is truly indebted unto UNITED VIRGINIA MORTGAGE CORPORATION, Richmond,  
Virginia, hereinafter called the Mortgagee, in the sum of Twenty-One Thousand One Hundred Sixteen and 84/100  
(\$21,116.84) Dollars, as evidenced by a promissory note of even date herewith, payable to the order of the Mortgagee in  
120 consecutive monthly instalments of Three Hundred Thirty-Four and 25/100-----  
(\$ 334.25 ) Dollars each, the first instalment being due November 15, 1980, and the remaining instalments

condition of said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor in hand well and truly  
paid by the said Mortgagee, at and before the sealing and delivery of these presents, the receipt of which is hereby acknowledged,  
have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto the said Mortgagee, its  
successors and assigns, the following described property:

ALL that certain lot of land lying on the Northeastern side of Lanewood Drive in Greenville County, State of South Carolina, shown as Lot No. 17  
on a plat of Pineforest, recorded in Plat Book QQ, at Pages 106 and 107  
in the RMC Office for Greenville County, S. C. and being further described  
according to said plat as follows:

BEGINNING at an iron pin on the Northeastern side of Lanewood Drive at the  
joint front corner of Lots Nos. 17 and 18 and running thence along the line  
of Lot No. 18, N. 26-59 E. 175 feet to an iron pin; thence N. 63-01 W. 100  
feet to an iron pin at the rear corner of Lot No. 16; thence along the line  
of Lot No. 16, S. 26-59 W. 175 feet to an iron pin on the Northeastern side  
of Lanewood Drive; thence along Lanewood Drive, S. 63-01 E. 100 feet to  
beginning corner.
