MORTGAGE

THIS MORTGAGE is made this 14th day of October, 1980, between the Mortgagor, Thomas W. Harrison and Mary B. Harrison, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Sixty-four thousand two-hundred and no/100 Dollars, which indebtedness is evidenced by Borrower's note dated October 14, 1980, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on October 1, 2009...;

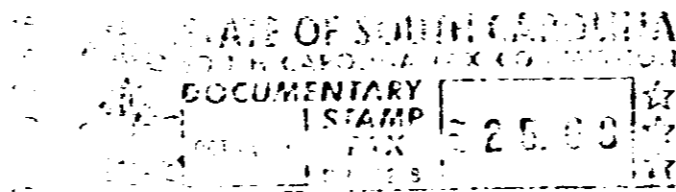
TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that lot of land situate on the northeastern side of Plantation Drive in the County of Greenville, State of South Carolina being shown as Lot No. 11 on a plat of Holly Tree Plantation, Phase III, Section I, dated September 1, 1978, prepared by Piedmont Engineers, Architects and Planners, recorded in Plat Book 6-H at page 74 in the RMC Office for Greenville County and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the northeastern side of Plantation Drive at the joint front corner of Lot 10 and Lot 11 and running thence with Lot 10 N 38-40 E 177-8 feet to an iron pin at the joint rear corner of Lot 10 and Lot 11; thence S 52-20 E 101.4 feet to an iron pin at the joint rear corner of Lot 11 and Lot 12; thence S. 29-27 W 178.2 feet to an iron pin on Plantation Drive; thence with said drive N 53-33 W 83 feet to an iron pin; thence still with said drive N. 51-54 W 47 feet to the point of beginning.

This conveyance is subject to any and all existing reservations, easements, rights of way, zoning ordinances and restrictions or protective covenants that may appear of record or on the premises.

Borrower covenants that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
