All that lot of land in Greenville County, State of South Carolina, on the northwestern side of Franklin Road, being shown and designated as Lot 235 on plat of Colonial Company dated February, 1938, prepared by Dalton & Neves, recorded in the RMC Office for Greenville County in Plat Book J at Pages 4 and 5 and being described, according to said plat more particularly to-wit:

BEGINNING at an iron pin on the northwestern side of Franklin Road at the joint front corner of Lots 235 and 236 and running thence along said road S. 32-58 W. 65 feet to an iron pin at the joint front corner of Lots 234 and 235; thence along the common line of said Lots N. 57-02 W. 200 feet to an iron pin at the joint rear corner of said Lots; thence along the rear line of Lot 235 N. 32-58 E. 65 feet to an iron pin at the joint rear corner of Lots 235 and 236; thence along the common line of said lots, S. 57-02 W. 200 feet to an iron pin, the point of beginning.

(1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgagor by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.
