

All that piece, parcel or lot of land situate, lying and being on the eastern side of Buckingham Way, in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 26 on a plat of Windsor Oaks Subdivision, Section 2, prepared by Kermit T. Gould, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 7-C, at page 13, and having, according to said plat and a more recent survey entitled "Property of Bob Maxwell Builders, Inc.", prepared by Freeland and Associates, dated October 20, 1980, the following metes and bounds:

BEGINNING at an iron pin on the eastern side of Buckingham Way, at the joint front corner of Lots Nos. 25 and 26, and running thence S. 56-26 E. 107.4 feet to an iron pin in the line of Lot No. 44; thence with the line of Lot No. 44, S. 15-24 W. 119.7 feet to an iron pin in the line of Lot No. 27; thence with the line of Lot No. 27 N. 78-06 W. 117 feet to an iron pin on the eastern side of Buckingham Way; thence with the eastern side of Buckingham Way the following courses and distances: N. 10-21 E 49.5 feet to an iron pin, thence N. 16-57 E. 49.9 feet to an iron pin, thence N. 31-32 E. 63.6 feet to the point of beginning.

This is a portion of the identical property conveyed to the Mortgagor herein by deed of Windsor Group, Inc., dated May 29, 1980, recorded May 10, 1980, in the RMC Office for Greenville County, South Carolina, in Deed Book 1126, at page 651.

In addition to and together with the monthly payments of principal and interest under the terms of the Note secured hereby, the mortgager promises to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80% of the original sales price or appraisal, whichever is less. The estimated monthly premium for the first nine years will be .02% of the original amount of the loan. The estimated monthly premium for each year thereafter will be .01% of the original principal balance of this loan. The mortgagee may advance this premium and collect it as part of the debt secured by the mortgage if the mortgagor fails to pay it.
