THIS MORTGAGE is made this 10th day of NOVEMBER, 1980, between the Mortgagor, Gerald E. Honeycutt and Dawn D. Honeycutt, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of FIFTY THOUSAND and 00/100 (\$50,000.00) Dollars, which indebtedness is evidenced by Borrower's note dated November 10, 1980, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on December 1, 2010.....;
