SEND GREETING:

WHEREAS, I the said Frances S. Wolfe

in and by my certain promissory note in writing of even date with these Presents, am well and truly indebted unto the Citizens Building and Loan Association, Greer, S. C., in the full and just sum of Fourteen Thousand and No/100 -----------------(\$ 14,000.00) Dollars, with interest from the date hereof at the rate of thirteen 3/per cent (13.7%) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of One Hundred Eighty-four and 10/100 ---

C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor... in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Citizens Building and Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, lying just outside the City of Greer and southwest therefrom and at the northeast intersection of Jones Ave., and Veron St., and being shown as all of lot number THREE (3) and a small part of lot number TWO (2) on plat of V. E. Cox by H. S. Brockman surveyor, recorded in plat book FF page 78, Greenville County R.M.C. Office and having the following metes and bounds, to wit:

Beginning at a stake at the northeast intersection of said two streets and runs thence with the edge of Vernon St., S. 34-30 E., 150 feet to lot No. 4; thence N. 33-00 E., 89 feet to stake in back line of lot No. 2; thence a new line throught Lot No. 2, N. 42-30 W., 145 feet to pin on edge of Jones Ave.; thence along Jones Ave., S. 33 W. 64 feet to the beginning corner. Property subject to right of ways of Jones Ave., and Vernon St.

Brockman, surveyor, dated November 11, 1960 and having the following metes and bounds according to said plat, to wit:

BEGINNING at a nail in the center of road that runs from St. Mark's Road to Rutherford Road (iron pin set on West side of 13 ft.) and runs thence N. 77-53 W. 213 feet along the line of Wibus Shirk to an iron pin, corner with Lloyd Reynolds; thence N. 24-39 E. 223.7 feet with Lloyd Reynolds to an iron pin; thence S. 62-10 E., 204 feet still with Lloyd Reynolds to a nail in the said road (iron pin set off 9 feet on west bank); thence with the said road S. 23-28 W., 166.5 feet to the beginning corner and containing 0.92 of an acre, more or less.
