

NOW, KNOW ALL MEN, that the mortgagor(s) in consideration of the said debt, and for the better securing the payment thereof, according to NOW, KNOW ALL MEN, that the marigagor(s) in consideration of the said debt, and for the better securing the payment thereof, according to the conditions of the said Note; which with all its provisions is hereby made a part hereof; and also in consideration of Three Dollars to the said marigager in hand well and truly paid, by the said marigages, at and before the scaling and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said marigages, its (his) heirs, successors and assigns forever, the following described real estate:

All that certain piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, being shown as Lot 17 on plat of property of R. E. Dalton made by Dalton & Neves, Engineers, November 1947, recorded in the RYC Office for Greenville County, S.C. in Plat Book S. Page 15, and having according to said plat, the following netes and bounds, to-wit:

Beginning at an iron pin on the north side of Sunny Lane joint front corner of Lots 16 and 17 and running thence with the line of Lot 16, N. 12-40 E. 599 feet to an iron pin in branch; thence down said branch as the line (the traverse linebeing N. 88-07 W. 228.3 feet) to a point in branch at rear corner of lot 18; thence along the line of lot 13, S. 11-45 W. 534 feet to an iron pin on the northside of Sunny Lane, thence with the north side of Sunny Lane, S. 70-45 E. 100 feet to an iron pin; thence continuing with Sunny Lane along curved line (the chord being S. 72-05 E. 117 Feet) to the beginning corner. This property is conveyed subject to the following building restrictions: 1. The lot herein conveyed shall be used for residential purposes only. 2. The lot herein conveyed shall never be sold, rented or otherwise disposed of toNegroes or persons of African descent. 3. No residence shall be erected on said lot costing less than \$2,500.00.

Being the same property conveyed to the grantors by R.E. Dalton by deed recorded in volume 359 page 29 of the R.M.C. Office for Greenville County.

As recorded in the records of the RMC Office for Greenville County, South Carolina, the title is vested in Wildon Gertrude White by deed of Ernest Anderson and Loretta E. Anders. son an recorded in Deed Book 448 at Page 411 on January 5, 1952.

IT IS HEREBY UNDERSTOOD THAT THIS MORTGAGE CONSTITUTES A VALID FIRST LIEN ON THE ABOVE TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining. DESCRIBED PROPERTY.

TO HAVE AND TO HOLD, all and singular the said Premises unto the said mortgagee, its (his) successors, heirs and assigns forever.

AND I (we) do heroby bind my (our) self and my (our) hetrs, executors and administrators, to procure or execute any further necessary assurances of title to the said premises, the title to which is unencumbered, and also to warrant and forever defend all and singular the said Premises unto the said mortgages its (his) heirs, successors and assigns, from and against all persons lawfully claiming, or to claim the same or any part thereof.

AND IT IS AGREED, by and between the parties hereto, that the said mortgagor(s) his (their) heirs, executors, or administrators, shall keep the buildings on said premises, insured against loss or damage by fire, for the benefit of the said mortgages, for an amount not less than the unpaid balance on the said Note in such company as shall be approved by the said mortgages, and in default thereof, the said mortgages, its (his) heirs, successors or assigns, may effect such insurance and reimburse themselves under this mortgage for the expense thereof, with interest thereon, from the date of its payment. And it is further agreed that the said mortgages its (his) heirs, successors or assigns shall be entitled to receive from the insurance moneys to be paid, a sum equal to the amount of the debt secured by this mortgage.

AND IT IS AGREED, by and between the said parties, that if the said mortgagor(s), his (their) heirs, executors, administrators or assigns, shall fail to pay all taxes and assessments upon the said premises when the same shall first become payable, then the said mortgagee, its (his) heirs, successors or assigns, may cause the same to be paid, together with all penalties and costs incurred thereon, and relimburse themselves under this mortgage for the sums so paid, with interest thereon, from the dates of such payments.

AND IT IS AGREED, by and between the said parties, that upon any default being made in the payment of the said Note, when the same shall become payable, or in any other of the provisions of this mortgage, that then the entire amount of the debt secured, or intended to be secured shall forthwith become due, at the option of the said mortgages, its (his) heirs, successors or assigns, although the period for the payment of the said debt may not then have expired.

AND IT IS FURTHER AGREED, by and between the said parties, that should legal proceedings be instituted for the foreclosure of this mortgage, or for any purpose involving this mortgage, or should the debt hereby secured be placed in the hands of an attorney at law for collection, by suit or otherwise, that all costs and expenses incurred by the mortgagee, its (his) heirs, successors or assigns, including a reasonable counsel fee (of not less than ten per cent of the amount involved) shall thereupon become due and payable as a part of the debt secured hereby, and may be recovered and collected hereunder.

PROVICED, ALWAYS, and it is the true intent and meaning of the parties to these Presents, that when the said mortgagor, his (their) heirs. executors or administrators shall pay, or cause to be paid unto the said mortgages, its (his) heirs, successors or assigns, the said debt, with the interest thereon, if any shall be due, and also all sums of money paid by the said mortgages, his (their) heirs, successors, or assigns, according to the conditions and agreements of the said note, and of this mortgage and shall perform all the obligations according to the true intent and meaning of the said note and mortgage, then this Deed of Bargain and Sale shall cease, determine and be void, otherwise it shall
