

AND IT IS AGREED, by and between the said parties that upon any default being made in the payment of the interest on the said ~~Deed~~ ^{Note} or of the insurance premiums, or of the taxes, or of the assessments hereinabove mentioned, when the same shall severally become payable, then the entire amount of the debt secured or intended to be secured hereby shall become due, at the option of the said Mortgagees, ^{their} executors, administrators or assigns, although the period for the payment thereof may not then have expired.
