TO ALL WHOM THESE PRESENTS MAY CONCERN: Charles D. Turner and Mary Jo C. Turner
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Associates Financial Services Co Inc
(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Fifty-seven Thousand Two Hundred Forty & no/100 DOLLARS (\$ 57,240.00),
with interest thereon from date at the rate of 18 per centum per annum, said principal and interest to be repaid: in 120 monthly installments of \$477.00 each, the first of said payments being due February 2, 1981, and a like installment due on the same day of each month thereafter until paid in full; said payments including interest at the rate of 18% per annum.
