MORTGAGE

THIS MORTGAGE is made this 9th day of January, 1981, between the Mortgagor, EARL M. ANDERSON AND MERRILY J. ANDERSON, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Sixty-Two Thousand Five Hundred and No/100 (\$62,500.00) Dollars, which indebtedness is evidenced by Borrower's note dated January 9, 1981, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on February 1, 2011.....;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that piece, parcel or lot of land situate, lying and being on the Southwestern side of Pine View Terrace, near the City of Greenville, in the County of Greenville, State of South Carolina, and known and designated as Lot No. 64 of a Subdivision known as Pebble Creek, Phase IV, Section II, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book 7-C at Page 47, and, according to said plat, has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwestern side of Pine View Terrace, at the joint front corner of Lots Nos. 63 and 64, and running thence with the joint line of said Lots S. 59-16 W. 150 feet to an iron pin; running thence N. 32-58 W. 75.55 feet to an iron pin at the joint rear corner of Lots Nos. 65 and 64; running thence with the joint line of said Lots N. 49-32 E. 149.12 feet to an iron pin on the Southwestern side of Pine View Terrace; running thence with the Southwestern side of said Terrace S. 34-35 E. 100.93 feet to an iron pin, point of beginning.
