 no/100ths -----DOLLARS (\$ 4,000.00),
 with interest thereon from date at the rate of ten per centum per annum, said principal and interest to be repaid: AT THE RATE OF \$100.00 PER MONTH UNTIL PAID IN FULL, WITH THE FIRST PAYMENT BEGINNING January 1, 1981.
