MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, We, ROBERT JOHN AYERS & BETTY CHAPMAN AYERS,

(hereinafter referred to as Mortgagor) is well and truly indebted unto LOUISE S. TODD

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of TWENTY-TWO THOUSAND FIVE HUNDRED AND NO/100----- Dollars (\$ 22,500.00 ) due and payable

in monthly payments of \$ 235.13 per month, commencing on and continuing at the rate of \$235.13 per month until paid in full, with each payment applied first to interest and balance to principal, with the right of prepayment in part or in full without penalty. with interest thereon from date at the rate of 9 1/2% per centum per annum, to be paid: monthly

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the Town of Simpsonville, on the eastern side of Holland Street, being shown and designated as Lot No. 19 on a plat of the D. N. Mayfield Estate, known as Mayfield Development, made by J. Q. Bruce, Surveyor, dated November 4, 1952, recorded in the RMC Office for Greenville County in Plat Book CC, page 199, reference to which is hereby craved for the metes and bounds thereof.

This being the same property conveyed to the Mortgagors herein by deed of the Mortgagee herein of even date herewith and recorded in the RMC Office for Greenville County simultanesouly herewith.
