THIS MORTGAGE is made this 16th day of January 1981, between the Mortgagor, Robert L. Bryant and Beverly Hom (herein "Borrower"), and the Mortgagee, South Carolina Federal Savings & Loan Association, a corporation organized and existing under the laws of United States of America, whose address is 1500 Hampton Street, Columbia, South Carolina, (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of ...
