leased, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

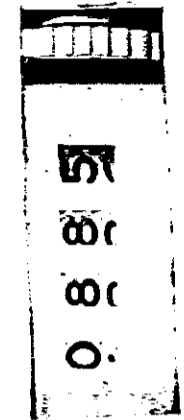
"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon,  
situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township,  
in the City of Greenville, situate on the East side of Main Street in  
said city, and beginning at a point 41 feet 8 inches from the Southeast  
corner of North Main Street and East North Street; thence with Main  
Street 16 feet 10 inches; thence 70 feet toward Brown Street; thence  
16 feet 10 inches toward East North Street; thence 70 feet to the  
beginning corner and being the same lot of land conveyed to Theo Croft  
Owens by Nicy Ann Wright by her deed dated November 1, 1895, and  
recorded in Deed Book BBB, Page 495, R. M. C. Office for Greenville  
County.

ALSO: All that certain piece, parcel or lot of land situate, lying  
and being in Greenville Township, Greenville County, State of South  
Carolina, on the East side of Main Street, and being more particularly  
described as follows: Beginning at a point on the South wall of what  
was formerly the Casino Theatre, and also formerly known as the Egyptian  
Theatre, which point is 70 feet East of Main Street; thence in an  
Easterly direction 30 feet 6 inches to a point; thence in a Southerly  
direction 58 feet 6 inches of Babb property; thence in a Westerly
