	1. That the loan balance at the time of this assumption is Fifty-One Thousand Two Hundred and Dollars;
	that the interest rate at the time of the assumption is 10.875 per cent per annum and the monthly principal and interest install-
	ments are Four Hundred Eighty-Two and 76/100 (\$482.76) Dollars; each with payments to be applied first to interest and then to remaining Principal, balance due from month to month with the first
	monthly payment due February 1, 1981; that the OBLIGOR agrees to repay said obligation on the terms and
	conditions set forth in the renegotiable rate promissory note, renegotiable rate mortgage and rider thereto and further agrees to be bound by all terms and conditions of said instruments as if his signature appeared thereon as the original borrower.
