"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Thompson Road and containing 5.70 acres as shown on plat of Property of Frances L. McCall recorded in the RMC Office for Greenville County in Plat Book SSS at page 459, and being more recently shown on plat of Property of Richard W. Borry and Margaret K. Borry recorded in the RMC Office for Greenville County in Plat Book 8-H at page 78, reference being craved to the more recent plat for a more particular cetes and bounds description.
