NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land in Greenville County State of South Carolina, being shown as Lot 45 on plat of Property of Don Wood, said plat being recorded in the RMC Office for Greenville County in Plat Book A at page 463 and having according to said plat the following metes and bounds:

Beginning at an iron pin on the southern side of Lindall Avenue formerly Lindal Street, said pin being 150 feet eastward from property now or formerly belonging to Honour, at the joint front corner of Lot 44, S. 15-20 E. 145 feet to an iron pin; thence N. 74-26 E. 50 feet to an iron pin at the joint rear corner of Lots 45 and 46; thence with line of Lot 46, N. 15-20 W. 145 feet to an iron pin on Lindall Avenue; thence with said Lindall Avenue, S. 74-26 W. 50 feet to the beginning corner.

Being the same property conveyed to the grantor by E. Inman Master, by deed recorded in Book 750, page 336.

This property is conveyed subject to restrictions, easements and rights of way of record affecting said property.
