"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Lawnview Court, being shown and designated as Lot No. 6 on a plat entitled PROPERTY OF WM.
