"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, between North Franklin Road and Brockman Avenue, being shown and designated according to a plat prepared by James R. Freeland, entitled "Property of Gary P. Patterson", which plat is dated June 1, 1979, and is recorded in the RMC Office for Greenville County, S.C., in Plat Book 7-H, at Page 24, and having such metes and bounds as shown thereon.
