MORTGAGE

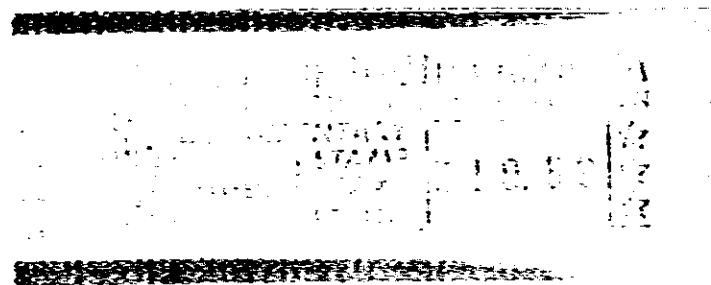
