TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, NORMAN B. WEST AND ELAINE G. WEST,

(hereinafter referred to as Mortgagor) is well and truly indebted unto

THE PALMETTO BANK,

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, in the Town of Simpsonville, Austin Township, being shown and designated as Lot No. 580, Section VI, of Westwood Subdivision, as shown on plat thereof recorded in Plat Book 4X, at Page 100, in the RMC Office for Greenville County, South Carolina. Reference is hereby made to said plat for a more particular description.

This being the same property conveyed to the Mortgagors herein by deed of Timothy J. Collins and Linda A. Collins dated June 20, 1978, and recorded June 26, 1978, in the RMC Office for Greenville County in Deed Book 1081, at Page 946.

It is agreed and understood that this mortgage shall be second and junior in lien to that certain mortgage given to Heritage Federal Savings and Loan Association recorded in the RMC Office for Greenville County on 6-26-78 in Mortgage Book 1436, at Page 241, and in the original amount of \$28,700.00.
