THIS MORTGAGE is made this 6th day of March 19. 81., between the Mortgagor Lynch L. Jackson (herein "Borrower"), and the Mortgagee, WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of the United States of America, whose address is 206 South Main Street, Woodruff, S. C. 29388 (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Nineteen Thousand and no/100 (\$19,000.00) Dollars, which indebtedness is evidenced by Borrower's note dated March 6, 1981 (herein "Note"), providing for monthly installments of principal and interest with the balance of the indebtedness, if not sooner paid, due and payable on March 1, 2003.

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina: All that certain piece, parcel or lot of land lying, being and situate in the State and County aforesaid, in Chick Springs Township, near Pleasant Grove Baptist Church, on the Eastern corner of the intersection of S. C. Highway No. 14 and Wood Drive, being known and designated as Lot No. One (1) as shown on plat of the J. A. Wood Lands prepared by J. Earle Freeman, Reg. Surveyor, dated October 9, 1940, which plat is recorded in the R. M. C. Office for said County in Plat Book FF, pages 200 and 201. This is the same property which was conveyed to John Aaron Mitchem and Crystal K. Mitchem by David A. Taylor by deed recorded in the said office on May 2, 1978 in Deed Book 1078, page 355. And this is the same property which was conveyed to mortgagor herein by John Aaron Mitchem and Crystal K. Mitchem by deed which will be recorded forthwith in the said office. For a more particular description see the aforesaid plat.

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
