# MORTGAGE

THIS MORTGAGE is made this thirteenth (13) day of March 1981 between the Mortgagors, Travelers Rest United Methodist Church (herein "Borrower"), and the Mortgagee, POINSETT FEDERAL SAVINGS AND LOAN ASSOCIATION of Travelers Rest a corporation organized and existing under the laws of South Carolina whose address is 203 State Park Road, Travelers Rest, S. C. 29690 (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Thirty-eight Thousand Three Hundred Forty-seven and 48/100, which indebtedness is evidenced by Borrower's note dated March 13, 1981 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on September 1, 2003

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville State of South Carolina:

**ALL that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being known and designated as Lot No. 41, Hampshire Hills, Section, plat of which is recorded in the RMC Office for Greenville County, Plat Book 5D, Page 79, and having according to said plat, the following metes and bounds, to-wit:**

**BEGINNING at an iron pin on the southerly side of Laconia Drive at the joint front corner of Lots 40 and 41; running thence with the joint line of said lots, S. 19-38 E. 210.4 feet to an iron pin; thence S. 66-34 W. 150 feet to an iron pin; thence N. 23-26 W. 215 feet to an iron pin on the southerly side of Laconia Drive; running thence with the said side of Laconia Drive, N. 66-34 E. 45 feet to an iron pin; thence continuing with the said side of Laconia Drive N. 64-11 E. 118 feet to an iron pin the point of beginning.**
