MORTGAGE

THIS MORTGAGE is made this 2nd day of April, 1981, between the Mortgagor, James Leary Builders, Inc., (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Forty-eight thousand and no/100 ----- Dollars, which indebtedness is evidenced by Borrower's note dated April 2, 1981, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on February 1, 2012.

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and being shown and designated as Lot 197 on the plat of Brentwood, Section No. IV, as recorded in the RMC Office for Greenville in Plat book 5D at page 43; and by a more recent plat entitled "Foundation Survey, Lot No. 197, Brentwood, Section No. IV." prepared by Richard D. Wooten, Jr. on January 22, 1981, and having, according to the more recent survey, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Brentwood Way, joint front corner of Lots No. 198 and 197, and running thence along the common lines of said lots N. 79-25 E. 130.0 feet to an iron pin; thence turning and running along the common line of Lots No. 196 and 197 S. 16-56 E. 168.9 feet to an iron pin on the southerly side of Brentwood Way; thence turning and running along said Way as follows: N. 82-43 W. 73.4 feet; N. 52-09 W. 71.94 feet; and N. 37-07 W. 71.53 feet to an iron pin; thence continuing on said Way N. 08-50 W. 27.55 feet to an iron pin, being the point of BEGINNING.
