(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Eight Thousand Eight Hundred Forty-Nine and no/100-----

Dollars (\$ 8,849.00) due and payable

in 180 consecutive monthly installments of Sixty-One and 15/100 (\$61.15) Dollars, due and payable on the 15th day of each month, commencing on May 15, 1981.

with interest thereon from said date at the rate of 3% per centum per annum, to be paid: monthly

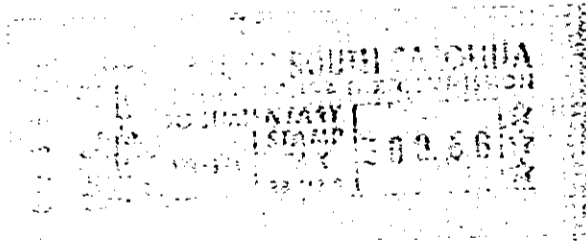

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE

ALL that certain piece, parcel or tract of land lying and being in the County of Greenville, State of South Carolina, being known and designated as lot 365 Section 2 of the Abney Mills, Brandon Plant, Subdivision, recorded in Plat Book QQ at Page 56 to 59 recorded in the RMC Office for Greenville County, S.C. by Dalton and Neves, Surveyors. This property is also known as 13 Mason Street, having a 66.6 foot frontage.
