WHEREAS, the said Mortgagor is truly indebted unto BARCLAYSAMERICAN/CREDIT, INC., hereinafter called the Mortgagee, in the sum of Twenty-Five Thousand Two Hundred and no/100 -----

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Coral Drive, being known and designated as Lot 15 of Coral Ridge as shown on a plat by Piedmont Engineering Service, dated March, 1964, recorded in the RMC Office for Greenville County in Plat Book XX, page 119, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Coral Drive at the joint front corner of Lots 15 and 16, and running thence along the joint line of these lots N. 80-16 E. 193.2 feet to an iron pin; thence S. 7-57 E. 90.0 feet to an iron pin at the joint rear corner of Lots 15 and 14; thence S. 80-14 W. 187.0 feet to an iron pin on the eastern side of Coral Drive; thence along the eastern side of Coral Drive, N. 11-38 W. 90.0 feet to an iron pin, the point of BEGINNING; and being the same property conveyed to Nellie S.
