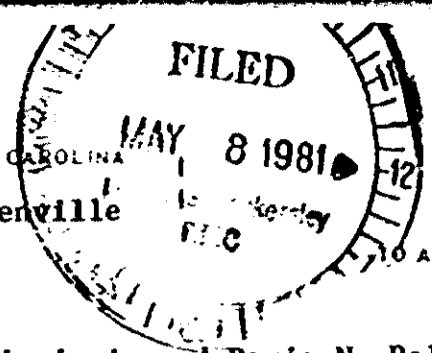

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of and other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

All that piece, parcel or lot of land together with buildings and improvements thereon lying on the Southern side of Chelsea Circle, in Greenville County, South Carolina, being shown and designated as Lot no. 40 on plat of Kirkwood Heights made by Pickell & Pickell Engineers, inc. dated October, 1954 and recorded in the RMC Office for Greenville County, S.C. in Plat Book E, pages 110 and 111, reference to which is hereby made for the metes and bounds thereof. The above described property is the same conveyed to the Grantor by deed of Clyde J. Moore and Irenee G. Moore recorded in the RMC Office for Greenville County in deed book 847 at page 415 and is hereby conveyed subject to rights of way, easements, roadways, setback lines and building restrictions applicable to Kirkwood Heights of Public record.
